Greetings,

Off and on for over the past 40 (forty) years I have been a part of or interested in the political process at a grass roots level. Currently I am employed, part-time, as the Gila County Sheriff's Office media liaison and serve in that same capacity to the Gila County Meth Coalition. I feel a person who is able to work with the media is an important part of any political committee. I am also the secretary (officially and unofficially) to several organizations including the Tonto Basin Residents, Roosevelt Residents Organization, the Tonto Basin Fire District Board and "Fishing With an Attitude " committee. A person who is able to take decent notes/minutes is also a vital necessity to any committee. Two of these assignments are covered under Arizona's Open Meeting Law..

So, why do I wish to continue offering my skills and abilities to Gila County? I worked for U. S. Senator Richard Lugar (R-IN) for 8 (eight) years in my home state. 





This letter is being address to you for consideration for the coming Redistricting Advisor Committee. My name is Adelaïdo Rodriguez and I go by Laido for short.


