

# MESA DEL CABALLO TRACTS

## PLAT NO 5

### A SUBDIVISION OF PART OF HES. 577, SECS. 23-24 T. 11N. R. 10E. G. 5R. 11T. GILIA COUNTY, ARIZONA.

**DESCRIPTION:** A portion of HES. 577 enclosed by four corners as follows: Beginning at a point on south boundary of HES. 577 which bears N 55° 27' W 660 FT; from Cor. 1083, which is 1/50 the SW corner of Plat #1, 'TESA DEL CABALLO TRACTS'; thence N 55° 27' W 543 FT to Cor. 4; thence N 20° 23' 30" E 2023.30 FT to Cor. 5 HES. 577; thence N 18° 54' E 1669 FT to a corner of Plat #1; thence S 71° 26' 11" W 1100 FT; thence N 18° 54' E 360 FT; thence S 55° 27' E 1371.83 ft along side of Stallion Road to center of Caballero Road; thence S 74° 06' W 1960 FT to point of beginning, enclosing an area of 4230 acres.

**DEDICATION**

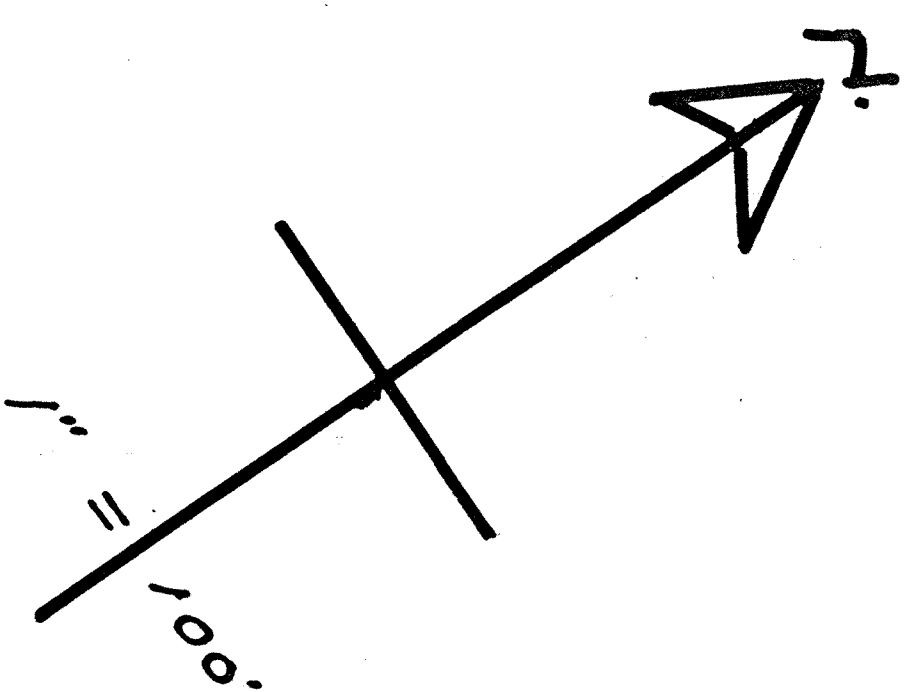
