

Proposer's comments:

District 3 is 4.4% regressive Latino. Otherwise it looks pretty good. Hope you like it.

Consultant's review comments:

The population deviation has been reduced to about one percent from the current six percent. Three geographic areas are disconnected from the rest of their new districts: Payson 8 is not touching any portion of the rest of District 2; East Globe, Part A is disconnected from the rest of District 4, and the Christmas/Hayden/Winkelman precincts are disconnected from the rest of District 5.

The voting-age minority proportions show moderate retrogression in District 3, which is largely an Anglo district. However, the non-contiguities affecting three districts makes the Voting Rights Act issues moot.
