Consultant's Review Comments:

This plan reduces the total population deviation by more than half, bringing the total deviation to just over 3%.

The 6 percentage point increase in voting-age minority proportion in District 2 bolsters that district's demonstrated ability to elect candidates favored by minority voters. Under this plan, the voting-age Native American proportion in District 3 also rises, but further analysis will be needed to determine whether District 3's minority populations will continue to be able to elect candidates of their choice. This plan has a lot of potential; a good starting point.

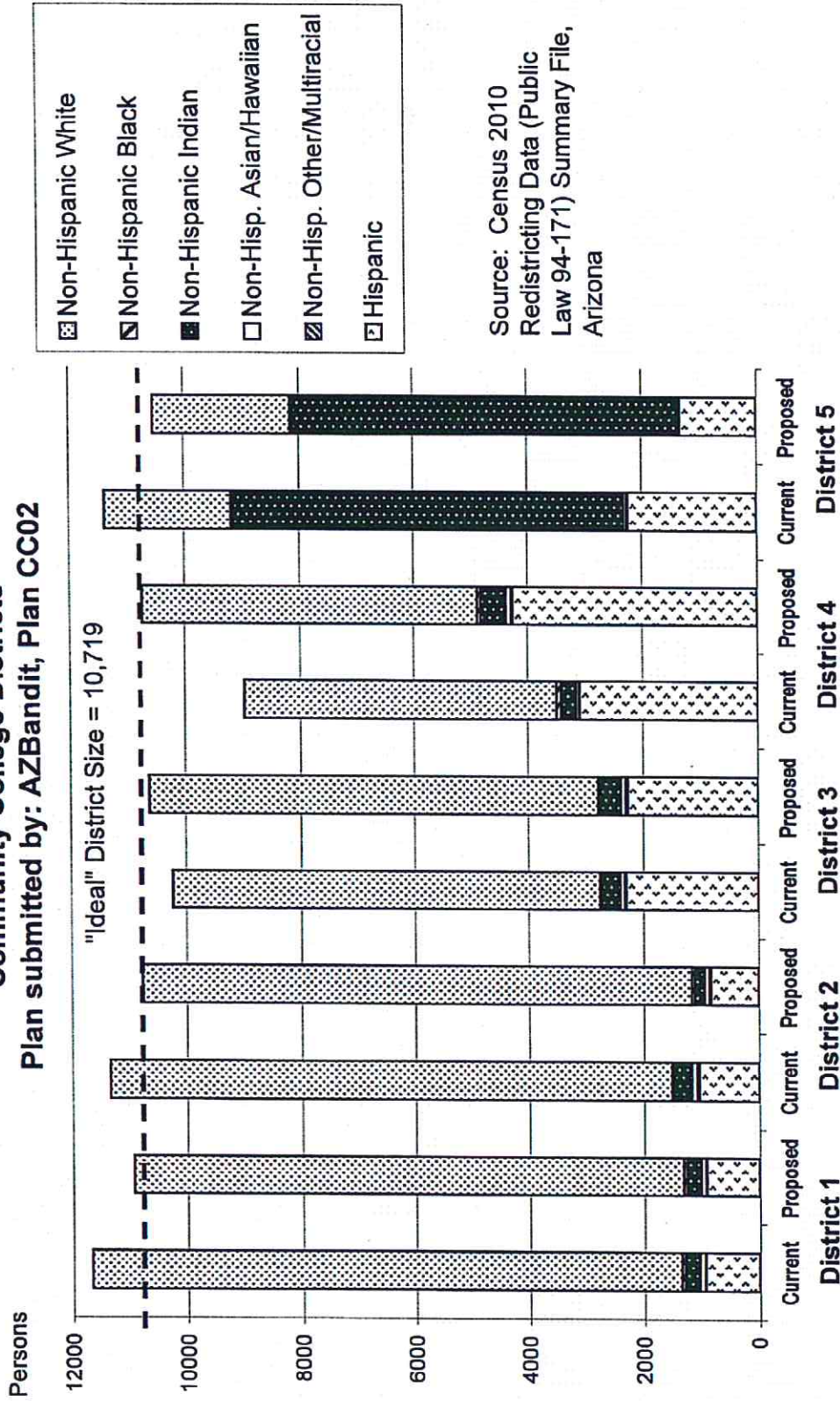
