SUPERVISER DAWSON:

My name is Robert W. Hibbert and I offering myself as a volunteer citizen of Star Valley, Arizona, for one of the positions on the Redistricting Advisory Committee of Gila County. I feel I have the experience to meet the needs of the decisions that relate to the geographical boundaries of the three supervisor districts in Gila County. It concerns me that the northern part of Gila County is included in all three districts when there are differences in the culture, population, and the tax base between the northern and southern parts of our county. From my point of view the northern part of Gila County is unfairly and not adequately represented.

I have lived in Payson and Star Valley, after being incorporated, for the past 10 years. My wife and I moved to Payson in January 2001 and temporarily lived in Payson until our home was built in the Knolls subdivision. Prior to moving to Payson I resided in Visalia, California for 36 years.

I am a college graduate, having graduated from Oregon State University in 1959 in the School of Education. I taught school in the Modesto, California, area and in 1964 became employed by State Farm Insurance Companies. I retired from State Farm in October 2000.

In 1980, in addition to my regular duties, I volunteered to handle natural disasters (hurricane, tornado, flood, hail storm, ice storm, and earthquake) in the lower 48 states. In 1995 I was requested to enter a special unit for a year related to the claims resulting from the Northridge earthquake in southern California. The first six months I exclusively handled claims involving "Agent's Errors and Omissions." My role was to resolve serious misconduct by some agents which resulted in inadequate earthquake limits of coverage for policyholders. I was charged to investigate those errors and to correct those deficiencies of coverage with policyholders. The second six months at the Northridge earthquake I served as a the company's negotiator relating to the payment to large Homeowner Associations and Apartment Complexes. This involved meeting with their boards and attorneys to educate and to solve the problems of the complexity of earthquake insurance.

I have been a registered Republican since I moved to Payson ten years ago. In 2001 I was elected as the Rim Country Republican Club's secretary/treasurer until 2005. I served as the interim president of that organization until a president was elected in 2010. I was encouraged to be a precinct chairman for the Republican party for Star Valley, but declined that position.

I have attempted to be involved in my community since my arrival in Payson in 2001. I have been an active member of Kiwanis for more than 45 years. As a result of my work in Kiwanis I was named in the Payson Roundup in 2002 as Payson's Role Model. Currently I am on the Town of Star Valley Planning and Zoning Commission and the Water and Sewer Commission.

My wife and I have been a board members of the Tonto Community Concert Board for the past six years. I spent two years meeting with the Arizona Department of Highways as co-chairman of the Gateway Project involving the landscaping of the round-a-bout at the intersection of Highway 87 and Tyler Parkway. Since 2002 I have been a CASA (court appointed special advocate) for children that are wards of the court.

I respectfully request that I be appointed as one of the people selected to redraw the district boundaries in Gila County.


