Dear Editor:

Your Voice Can Make a Difference!

Several weeks ago, we submitted a letter to the Moccasin to inform readers about the big private prison that a handful of Globe and Gila County Officials want to build alongside the County Fairgrounds. Let us share with you what is happening now.

For-profit prison contractors submitted bids to the AZ Department of Corrections on February 24. The same company that came to town last April to sell their 'promises' about a private prison, once again put in a bid to build a 1,000-bed, medium security facility in Globe. They claim that the prison would be

designed so that it could double its capacity to 2,000 beds.

The new Request for Proposal (RFP) issued by the DOC, stipulates four prison expansion sites, and Globe was not among those four sites. However, the possibility for a private prison to be located in Globe was not absolutely ruled out. We expect the DOC to award bids within 45-60 days. A Public Hearing will be scheduled in communities where bids are awarded.

We have spoken to many, many residents from San Carlos who believe that a for-profit prison enterprise is not the sort of 'economic development' that citizens would be proud to support. Nearly everyone asks the same basic questions:

"Why on earth do some of the elected leaders from Globe and Gila County think we want a private prison? Would these elected officials want to work inside a private prison? Did these elected officials seek genuine input from both communities BEFORE moving ahead with such a plan? Why won't these 'leaders' listen to the majority of their constituents and represent the will of the people?"

These basic questions deserve honest answers. Instead, we just hear the private prison 'talking points' repeated over and over. Unbelievable! Globe's Mayor Shipley and County Supervisor Dawson need a civics lesson in representative democracy. Instead of referring to an imaginary "silent majority" to justify their actions, they should listen to the REAL people who elected them to office. Most of their constituents continue to say loud and clear, "We do NOT want a private prison project in our community—period."

Your voice can make a difference! You can let the elected leaders of the San Carlos Apache Tribe know where you stand on this issue. And, you can think about the importance of future elections for Gila County Supervisor. Our elected officials should listen respectfully to the people, and represent them well. Dear Editor,

Last month, at Fort Thomas High School a male employee had improperly touched a high school student on her thigh area several times. The girl was frightened and reported the incident to her teacher and the teacher referred her to a school counselor. And the school counselor didn't take the student's statement seriously and took no action on behalf of the frightened student.

The incident was reported to the school official the following day by the girl's parent. And the Sheriff Department was contacted and interviewed the girl and the male employee. The girl and her family were dismayed no action was

taken. It seems the male high school employee can continue to make improper sexual advances on minor girls on school campus as he pleases because there's nothing wrong with it. What kind of message is this?

It appears the Fort Thomas High school has no policy against sexual harassment and child molesting. If there is no policy, the students are not safe and they have no protection against a potentially dangerous child molester on school campus.

How many Apache girls have been molested at the high school? And how long has it been going on? Molest means to make improper sexual advances and to

cause harm. It's obvious some girls are afraid of this male employee at the high school.

The victims usually are scared to come forward to report on the molester.

The victims need encouragement and protection so they can come forward without fear and report this child molestation so other young innocent girls can be safe at school.

A word of advice. Please talk to your children, ask them if they have any problems at school that as a parent you need to know. Encourage them and support them, express your concern and sincere love and care for them.
