## Freeport-McMoRan Copper and Gold, Inc. Compensates \$76.3 million for two top officials

The mining company's chief executive officer Richard Adkerson's salary last year was \$2.5 million, but his total pay package jumped more than 40 percent to \$39.5 million according to the *Phoenix Business Journal*.

Adkerson, in addition to his salary, received stock awards totaling \$5.82 million; stock options, \$15.4 million; incentive plan, \$10 million; change in pension value and deferred compensation, \$4.24 million; and other compensation listed at \$1.56 mil-

lion according to the publication.

Meanwhile, James Moffett, Chairman of Freeport-McMoRan Copper & Gold had a total compensation package last year of \$36.8 million which is up from \$21.5 million in 2009.

Moffett's total compensation package breakdown was salary, \$2.5 million; stock awards, \$5.82 million; stock options, \$15.4 million; incentive plan, \$10 million; change in pension value and deferred compensation, \$1.24 million; and other compensation, \$1.77 million, according to the *Business Journal* report.

## Sanitary Districts Consolidation Election ballots due May 17

The Pinal Sanitary District and Cobre Valle Sanitary District are working to consolidate into one organization and the Gila County Election Department has sent out mail-in ballots which are due back by May 17.

Residents of the two districts are asked to vote in favor of consolidation by the boards of directors of the two districts to facilitate conducting business. Currently, the two boards meet together under an Inter-Governmental Agreement and consolidation would streamline the process.

Residents affected live in the unincorporated areas between the City of Globe and the Town of Miami: Lower Miami, Claypool, Little Acre, Midland City, Bandy

Heights, Central Heights and Country Club Manor. The geographical area of Pinal Sanitary District is the same as the Tri City Fire Department and Cobre Valle Sanitary District is located in what used to be Central Heights Fire District.

Tri City and Central Heights fire districts voted to consolidate about eight years ago; the two sanitary districts are trying to do the same thing.

The newly consolidated district, if the election succeeds, would be called the Tri City Regional Sanitary District.

Eleven-year-old Isaiah Tarango, Cinco De Mayo's Junior King took some time out Monday between school and softball to talk about his rise to the top.

When Isaiah learned that Cinco De Mayo would be crowning kings for the first time this year, he knew he wanted to compete.

"I thought it would be a good experience," he said.

He already knew the ropes. He had run for Fiesta King at Our Lady of the Blessed Sacrament twice and won. He knew he had what it takes.

He enlisted the help of his family and friends and was able to raise \$1,400 selling raffle tickets for an I-pad and a \$100 cash prize. He also raised money for the March of Dimes and walked 6.4 miles to support the charity. Even at 11, he has a special place in his heart for the March of Dimes. "It's to support the kids who have cancer and need operations," Isaiah said.

There was other work to do as well like attending workshops for the potential royalty. "They told us

There were times when his con-

fidence dimmed a little like when he heard his competitors were stepping up their fund raising activities and when he went for his interview with the committee. "They asked, 'what's your platform?' I don't even know what that means," Isaiah said. After some quick thinking, he told them it was to raise awareness of smoking. He has only one word for those who smoke: "Stop."

His favorite part of running for king was the new people he met like Elisia, the boy who won the title of Little King. "He's pretty cool," Isaiah said. "He was funny." When he was finally crowned, he wanted to wear the head piece all the time. "It was silver with those little club looking things on top of them," he said.

He did take it off for a little while to let his three-year-old little brother, Matthew, try it on. "Yeah, it fit him," Isaiah complained. The crown had to be bent to fit big brother's head.

Once the crown fit, Isaiah didn't see why he couldn't wear it anywhere including to take the trash out. "It's mine," he said.

Isaiah had a good idea of what he would decree if he really was royalty with kingly powers. "I'd make Miami bigger with more money so they can buy what they need," he said.

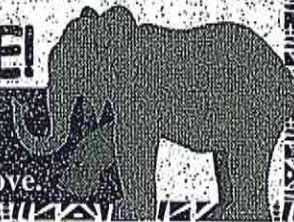

# Globe Police Department mourns death of Officer Schell

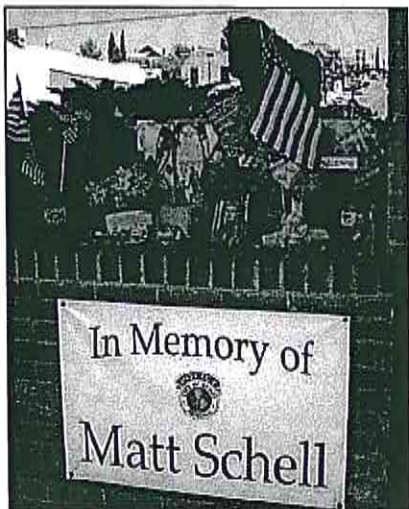

For seven months he lay with no expectation that he would live much less recover. "I didn't know nothing about it," he said. "The good Lord wouldn't let me in and the devil said, 'Hell, no.'"

"I was an explosives engineer and the war was on yet when I got out of the hospital," Miller said.

"When I was being discharged, they told me, 'Rocky, we need you at Caribou Hill. You don't need to work. We just need your know-how.'"

That began a life long on-call relationship with the United States government. Even after being discharged from the service, he continued to receive calls to help with explosives. "In the 50's and 60's they called me 10 or 12 times a

year," he said. "They shipped me all over. So far this year, they've only called me once," he said.

Although he doesn't drive, Miller carries his license as proof of his age. His birth date is listed as March 4, 1913.


"In less than two years, I'll make it to 100," he said. A great life for someone who was killed in action in the early years of World War II.
