

For over the past five years I have been a volunteer veterans service advocate assisting hundreds of veterans in the Payson and surrounding areas from every service period, WWII to present. I am on call with the Payson police department, Chief Engler, and local court, Judge Little, to respond to veterans in need of assistance. I am also currently on the Payson town Housing Review Committee. Giving back to my community is important to me.


I am a graduate of California State University Long Beach, 1972, with a bachelors degree in Political Science and a minor in Business. I choose the business route for my career and was very successful in the corporate world as well as in private business. While employed in the Automotive OEM markets I rose to executive management and had the privilege of being recruited to be part of the management team which brought Isuzu into the United States marketplace. Various programs and procedures which I implemented at Isuzu were replicated by other automotive import OEM's and are currently in use at both corporate offices and manufacturing assembly plants. I spent twenty years in various corporate positions and in 1988 left to open my own business.

I started a urethane production company, American Protective Coatings, and small aero space company, UTI. I was the first person to offer a spray-in-bedliner to the retail automotive marketplace in Los Angeles. This was a difficult task with relentless meetings/showings to show the features and benefits of my product all the while explaining the increased profit margin my product offered the dealerships. This became a very successful business and today has an international product acceptance. I did not invent this product, rather I understood the features/benefits and potential marketplace and simply took action to be one of the first companies to offer the product. I developed and started an Aero Space company, UTI, and was awarded numerous contracts to make raceway panels for the Titan and Delta III & IV rockets. I always felt a sense of accomplishment when I knew one of my parts was in a rocket being fired into space. I sold my business in 2005 and retired which now allows me to give back by involvement in my community.

I was drafted into the Army in 1965 and because of my high test scores was offered the opportunity to go to Officers Candidate School. I accepted this opportunity and graduated eighth (8) in my class of two hundred fifty (250) candidates. I had various assignments during my three plus years in the army to include an assignment as a Combat Platoon Leader in Vietnam. I was given command of 2nd platoon, Alpha Company, 4th Battalion 9th Infantry Regiment 25th Infantry Division during some of the highest combat action in the war, 68 TET offensive. I consider this combat command experience to be one of the highest privileges I have ever had. Unfortunately, a lot of men were wounded in combat under my command but none of my men were killed. Among other awards I have the Combat Infantryman Badge, Purple Heart with oak leaf cluster (two awards) and Silver Star for Gallantry in action.

I believe that my community involvement, my military and my personal career experiences place me in a positive position to be of service as a member of the Gila County Redistricting Advisory Committee.

I would like to thank you for this opportunity to submit my letter of interest for participation in the Redistricting Advisory Committee.



I have served as inspector for the Gila County elections board for many years.


I am a retired federal government employee as an agent for the Internal Revenue Service.
